The Grundy County Board of Health (LBOH) met on Tuesday, January 23rd, 2024, at 7:00am in the Conference Room at the Grundy County Annex Building in Grundy Center, IA. Environmental Health Possible Action Regarding Lon's Plumbing & Heating: Additional information was allowed into the record of email exchanges between Sparks, Darren Hasselman, and Corey Frank. Those were sent to the board via email, but not available day of hearing on 1/16/24. The other piece allowed into the record was the letter that Erika sent to Pat Galles dated November 7, 2023 offering a clarification on the Dbox depth.
