

BOARD OF SUPERVISORS PROCEEDINGS

The Grundy County Board of Supervisors met in a regular session in the Supervisors' room at the Grundy County Courthouse on June 2, 2025, at 9:00 a.m. Chairperson Nederhoff called the meeting to order with the following members present: Vandehaar, Pabst, Kopsa, and Schildroth.

The Board opened the meeting by reciting the Pledge of Allegiance.

Motion was made by Kopsa and seconded by Vandehaar to approve the minutes of the previous meeting. Carried unanimously.

At 9:01 a.m. Chairperson Nederhoff opened the public hearing about the proposed budget amendment.

There was nobody present from the public who spoke in favor of or against the budget amendment.

At 9:04 a.m. Chairperson Nederhoff closed the public hearing.

Motion was made by Pabst and seconded by Schildroth to adopt the FY2025 County Budget Amendment as published and to introduce Resolution #49-2024/2025 regarding budgetary appropriations changes.
