

**RESOLUTION FOR ROAD VACATION PUBLIC HEARING**

*Grundy County*


*Resolution No. 18-2011/2012*

**WHEREAS**, A request (or petition, or a memorandum from the County Engineer) has been filed with the Grundy County Board of Supervisors (or County Engineer) asking that action be taken to vacate and close (or to vacate and clear the record, if it was not open to traffic) a section of Grundy County Secondary Road, described as follows:

That portion of C Avenue, originally established by Road Record Book No. 2 Page 26, all lying in Section Nineteen (19) and Twenty (20), Township Eighty-eight (88) North, Range Eighteen (18) West of the 5th P.M., Grundy County, Iowa. The intention of this road closure is to vacate the portion of public road original with modifications more particularly described as: The east 33 feet of the the Southeast One-quarter of said Section 19 except the south 400 feet thereof, and the west 33 feet of the Southwest One-Quarter of said Section 20 except the south 400 feet thereof.

Easement access rights shall be granted to all existing utilities on said described road vacation to allow access to their current facilities, now and in the future, for maintenance, repair patrol, operation, and reconstruction of said facilities.

**NOW, THEREFORE BE IT RESOLVED** that a hearing on the proposed vacation will be held in the Board Room, Grundy County Courthouse, Grundy Center, Iowa, 50638 at 9:00AM on 27th day of December, 2011 in accordance with Iowa Code Chapter 306.




