

ATTENTION GRUNDY COUNTY RURAL LANDOWNERS

**SIGN UP NOW FOR DUST CONTROL SERVICE**

The Grundy County Engineer's Office will allow private contractors to apply dust control within the county. Neither Grundy County nor the Grundy County Board of Supervisors assumes any responsibility for this service.

The cost of this service will vary slightly between contractors. Please see the Grundy County website for the list of contractors to request pricing details and to complete the transaction.

Self-applicators will be required to submit a permit with the county. The permits are available from the Grundy County Engineer's Office at 22580 M Avenue, Grundy Center. There is no fee for the permit.

**Should grading or blading of any dust control treated roadway become necessary, by the opinion of the County, due to unsafe roadway surface or weather-related conditions, such grading or blading will be done by the County without notice and no refund of application costs or retreatment of surface will be made.**

The signup deadline for this service is Friday, April 18<sup>th</sup>. **No late sign-ups will be allowed.**

**Notice to Applicators of Used Motor Oil**

**EPA has ruled that used motor oil is no longer permitted on county roads as a dust suppressant. Anyone who applies used motor oil on county roads is in violation of state and federal environmental regulations.**

**\*PLEASE NOTE\*:**

Please stop by the Grundy County Engineer's Office at any time to pick up flags which will be located outside our office near the front door in a white PVC tube for your convenience. Please mark the start and end location of where you would like the application of dust control. If no flags are posted, the contractor will automatically center the application along your property.

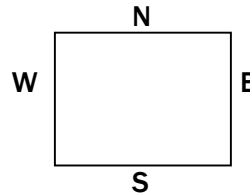

**CONDITIONS OF PERMIT:**

The application and maintenance of chemicals on crushed rock surfaced roads to control dust shall be by permit only, and in accordance with the below Grundy County Fugitive Dust Control Policy and the applicant agrees to the following conditions:

1. Dust control chemicals may be applied by an approved contractor and/or landowner.
2. Materials approved for use on the roads include calcium chloride, and lignin sulfonate.
3. The landowner shall be responsible for maintaining potholes and rough spots in areas applied with dust control chemicals. Should grading or blading of any dust control treated roadway become necessary by the opinion of the County due to unsafe roadway surface or weather related conditions, such grading or blading will be done by the County without notice and no refund of application costs or retreatment of surface will be made.
4. County Engineer’s Office (319/824-6912) shall be notified 5 working days in advance of applying a dust control agent, so the roadway may be properly shaped.
5. Grundy County will not assume responsibility for any dust control service.
6. Grundy County will blade through dust control areas during the month of October to prepare road for winter, without notice to landowner.
